

Service description for the module Mercateo Exclusive Catalogue

The module Exclusive Catalogue makes it possible for the Company to extend the Mercateo procurement platform with electronic product catalogues (exclusive catalogues). The exclusive catalogues may complement the product range of the Mercateo procurement platform. The contractual relationship existing between the Company and their suppliers shall remain unaffected. The supplier shall continue to be the contact point for the Company.

The purchase agreement regarding the catalogues related to framework agreements negotiated by the Company (exclusive catalogues) that have been integrated on Mercateo shall be concluded exclusively between the Company and the respective exclusive supplier. For that purpose, Mercateo shall grant the right to use the procurement platform to the Company and the users authorised by the Company.

§ 1 Formats

1. In the scope of the integration, the exclusive catalogue shall be uploaded by the Company or their suppliers in one of the following formats to a server provided by Mercateo:
 - BMEcat (Version 1.2)
 - Mercateo CSV
2. With every article, the following items may additionally be delivered:
 - Images
 - Product data sheets
 - Safety data sheets
 - Inventories
 - Signs
 - Safety-relevant information
 - Customer-based information

§ 2 Integration

1. An integration may not be carried out unless the supplier accepts the General Terms and Conditions regarding the participation in the Mercateo platform.
2. Mercateo shall provide the supplier with an access to the FTP server in principle within a period of fourteen business days after the submission of all required data by the Company.
3. The Company shall be solely responsible for the complete and correct transmission of the required data and catalogues.
4. Mercateo shall inform the Company about the progress of the process.

§ 3 Catalogue Administration

1. Mercateo shall provide the Company and the supplier with a system for the administration of the exclusive catalogues.
2. Orders from a new or amended catalogue shall only be possible after the Company has activated the catalogue in the catalogue administration system.

The Company and Mercateo agree on the aforementioned performance of the module Mercateo Exclusive Catalogue. The General Terms and Conditions of Mercateo and, if applicable, the agreement regarding the utilisation of the Mercateo procurement platform form part of this contract. Prices are based on the applicable price list at the time of the conclusion of this contract. This contract may be terminated in writing with a notice period of 3 months to the end of the month.
